## IV. General Manager's Report

- \* June 2018 ending account balance was \$62,174.43. June 2018 water bill to City of Clayton was \$101,048.14 for 33,570,810 gallons, an increase of 2,301,020 gallons (7.4%) over May 2018.
- \* LTWTP pumped to distribution system for June 2018 was 13,873,000 gallons; a decrease of 780,000 gallons or -5.3% from May 2018.
- \* Meter readings for June 2018 were taken by RCWSA on June 25, 2018. Bills were sent out on June 29, 2018.
- \* Mr. Thompson stated there were 0 new taps for June 2018.
- \* Unaccounted for water volume for June 2018 was 4.7%.

Continuing work on Line A (8-inch sanitary sewer) along Old 441 south along the east side of Old 441.
