

# Rabun County Water and Sewer Authority Meeting Minutes February 9, 2021

#### I. Call to order

Chairman Sam Beck called to order the February 2021 regular business meeting of the Rabun County Water and Sewer Authority (RCWSA) at 10:00 AM February 9, 2021, at the Rabun County Water & Sewer Authority Business Office.

## IV. General Manager's Report

- \* January 2021 ending account balance was \$189,520.84. January 2021 water bill to City of Clayton was \$97,641.38. The pumped to distribution system volume for the South Water System (LRWTP) for January 2021 was 36,317,000 gallons; a decrease of 2,967,000 gallons or -7.6% from December 2020.
- \* City of Clayton's January 2020 volume was 30,657,217 gallons and January 2021 volume was 30,608,582 gallons; a decrease of 48,635 gallons or -.2% from January 2020 to January 2021.
- \* North Water System (LTWTP) pumped to distribution system for January

2021 was 13,508000 gallons; an increase of 767,000 gallons or 6.02% from November December 2020.

- \* Meter readings for January 2021 were taken by RCWSA on January 25, 2021. Bills were sent out on January 29, 2021.
- \* Mr. Thompson stated there were no new water taps for January 2021.
- \* Unaccounted for water volume (South Water System) for January 2021 was 7.10%.
- \* Unaccounted for water volume (North Water System) for January 2021 was 8.10%.
- \* Mr. Thompson stated that electrical service was done on influent pit pumps at Rabun County Water Reclamation Facility.
- \* Fire hydrant maintenance and valve exercising is ongoing.
